### Introduction

The Government of Kenya established the Konza Technopolis Development Authority (KoTDA) as a special purpose entity to facilitate the development of Konza Technopolis. The mission of KoTDA is to ensure that Konza grows into a sustainable, world-class technology hub and a major economic driver for the nation, with a vibrant mix of businesses, workers, residents, and urban amenities. KoTDA is responsible for overseeing the development and management of Konza, and for establishing a strong value proposition for businesses to locate and expand in Konza.

KoTDA is a full member of International Association of Science Parks and Areas of Innovation (IASP) effective February 2020. The Authority is scheduled to host the IASP Africa Division Web Forum on 18th March 2021. The event will bring together IASP Africa leadership, global players in the technology space and key stakeholders in the Science and Technology Parks (STPs) to discuss "The Place of STPs in Africa's Economic Recovery - Impact of the African Continental Free Trade Area Agreement"

# Background

The IASP is an independent, non-profit, non-governmental, membership-based organization with a worldwide network. The Association is a leader network in the Science Parks and Areas of Innovation spaces and plays the following roles:

- 1. Coordinates an active network of professionals that manage areas of innovation and science/technology parks.
- 2. Enhances new business opportunities for companies and research organizations located in these areas.
- 3. Assists the development and growth of new parks and other areas of innovation.
- 4. Increases the international visibility of its members and sponsors.

## **IASP Africa Division**

IASP has seven divisions namely Africa, Asia Pacific, Eurasia, European, Latin American, North American, West Asia and North Africa. The Africa Division is headed by Ms. Hauwa Yabani of Abuja Technology Village FZ Co., Nigeria. The global economy is facing a deep recession due to the impact of COVID-19 pandemic. To reignite the economy, the African continent must pull together as one to build a better future for the continent. STPs and areas of innovation need to work together with shared goals guided by the African Continental Free Trade Area Agreement to find innovative solutions to the continent's most pressing challenges.

The IMF Regional Economic Outlook Report 2020 has placed the regional growth at 3.1 percent in 2021 with key drivers of growth being cited as export and commodity prices. This calls for an innovative approach to pushing the continent's competitiveness and unleashing the potential of the youth within the innovation spaces to drive economic growth. The conference seeks to provide this much-needed platform.
